ICI is a 501(c)(3) nonprofit that provides fiscal sponsorship, incubation, and employment administration services to emerging nonprofits and special initiatives through New York State and nationally. This past year, ICI provided fiscal sponsorship services to 19 emerging groups, including government grant management, and employment administration services to 6 nonprofits, employing 28 staff on their behalf. ICI clients are diverse; representing public radio, arts, food pantries, cancer research, early childhood

education, career training, youth engagement in sports, and neighborhood preservation. Community Foundations are a primary referral partner for ICI.





Governance Matters, Inc.

Governance Matters, our newest family addition, has long set the standard for developing strong, effective boards with a specialty in board recruitment and placement, board consulting and training, and "best practice" educational roundtables, tools and resources. Governance Matters sponsors boardnetUSA, the nation's first and premier board matching website. This past year, we merged the Volunteer Consulting Group, Inc. with Governance Matters, Inc. with funding support from the New York Merger and Acquisition Fund (NYMAC) and the Dyson Foundation. Governance Matters also received program grants from the Altman Foundation and the New York Community Trust. Additionally, S&P Global and the First Nonprofit Foundation provided

grant support to technologically upgrade boardnetUSA.

TECHNICAL ASSISTANCE AND CONSULTING


NYCON's technical assistance, consulting and training reflect the very heart of our commitment to expert and affordable capacity-building services that are responsive to the real and practical needs of our nonprofit community. We are a one-stop-shop for nonprofits seeking reliable, trusted and affordable customized assistance to meet short- to long-term needs; instill best practices to resolving the most difficult organizational issues; and from nonprofit formation to acquisition, merger and dissolution. Our integrated multi-disciplinary team approach is designed to resolve problems and increase organizational performance, accountability and sustainability.



NYCON has to date successfully assisted 59 corporate affiliations from around the state. This past year, we were also the sole provider for Berkshire Nonprofit Solutions, in Massachusetts, where we provided a community-wide training on affiliations; technical assistance to over 25 nonprofit organizations interested in affiliation solutions; and facilitated and supported two negotiations.

Community Planning

NYCON's history is rooted in mobilizing nonprofits, government and the private sector in meeting community needs. This past year we continued our facilitation work with Schenectady County Public Health's **Strategic Alliance for Health (SAH) Coalition** through a federal grant from Centers for Disease Control in 2014. OUR IMPACT

PUBLIC POLICY

While NYCON often assists both our members and policymakers with understanding current laws (and potential implications of proposed laws), we also proactively participate in the legislative process. Areas of impact last year include, but are not limited to the following:

- Nonprofit Indirect Contracting Costs Participated in a coalition urging both the State and NYC to adopt their own nonprofit contracting standards that mirror those currently imposed on federal funds (Uniform OMB Guidance).
- Third-party Violence Prevention Infrastructure Successfully spearheaded a veto on legislation carrying an intrusive and unfunded requirement that nonprofits make indefinite and unreasonable alterations to their facilities and operations.
- Federal "Nonprofit and Education Property Protection Act" -Working with CS Plus and the Alliance for Nonprofit Insurance, we supported a bill that will allow 501(c)(3)s to access liability insurance from a Risk Retention Group.



- NYS Prompt Contracting We offered ongoing personalized assistance to members, and have shared our field monitoring prompt contracting experiences with the State, in an effort to compel the state to more effectively meet its obligations.
- Nonprofit Administration Disclosures We solicited our membership to actively oppose a bill that would have required nonprofits to place on post-donation receipts, the amount of the donation that went to "charitable work" as opposed to "other purposes", including but not limited to administrative expenses.
- Amendments to Not-for-Profit Corporation Law Amendments The legislature had forwarded more amendments to the law and we have urged the Governor to veto the bill as we see some key elements as detrimental to the sector.
- Unfunded Mandate on Small NYC Nonprofits for Energy Sustainability Audits We opposed this bill on the unnecessary financial burden it would place on nonprofits. No further actions or votes were taken.
- NYS Donor Confidentiality Ethics Legislation NYCON opposed the intent of this bill which passed as part of an overall ethics package and requires 501(c)(3)s that provide \$2,500 in monetary or in-kind support to 501(c)(4) nonprofits, to file a report for the period that all donors to the charity whom contributed \$2,500 or more to the AG. NYCON is providing input to the AG's Charities Bureau to assist in the development of implementing regulations.

Launching the First #NYGivesDay

❖ New York State Department of Health AIDS Institute Fiscal Capacity Program

We are excited to announce this coming year will be our first full implementation year of a \$1.2M, 5 year award. NYCON was selected through a competitive bidding process as the sole vendor to provide fiscal and organizational technical assistance to grantees of the AIDS Institute.

Conservation for the Art & Historic Artifacts Contract (CCAHAC)

This year will also be the first full implementation year for a very unique 5 year, \$228,000 statewide planning process to prioritize the digitization of documents and materials of historic significance. NYCON will be responsible for much of the data collection, conduct 45 local strategic plans and provide a "train-the trainer" for the other 45 strategic plans.

Governance Matters / boardnetUSA

The coming year will be our first full year of working with our newest family member, Governance Matters. In NYC, there will be robust educational roundtables on governance issues and practices that matter to nonprofits. TREASURER'S REPORT

JULIE H. KRIEGER, TREASURER, BOARD OF DIRECTORS

On behalf of the Board of Directors, I am pleased to present a summary of NYCON, Inc.'s independently audited Consolidated Financial Statements for calendar years 2015 and 2014. The Statements are presented on the pages following this summary.

The results of our audit included the issuance of an unqualified opinion, stating that the financial statements presented fairly, in all material respects, the financial position of NYCON and its affiliates as of December 31, 2015. We are also pleased to report that our auditors did not identify any deficiencies in internal controls that would be considered a material weaknesses. NYCON's family includes the consolidated books and records of NYCON, Council Services Plus, Inc; Innovative Charitable Initiatives, Inc; and our newly acquired affiliates, the Volunteer Consulting Group, Inc. (VCG) and Governance Matters, Inc. VCG and Governance Matters were acquired as subsidiaries in May 2015 and were merged in 2016, retaining the corporate name, Governance Matters, Inc.

The audited results of NYCON and its affiliates, reported Unrestricted Net Assets of \$404,185 and Temporarily Restricted Net Assets of \$58,961 that totaled at year-end \$463,146. The change in unrestricted Net Assets of NYCON and its affiliates for fiscal year 2015 was reported at a negligible loss of (\$14,134), related primarily to NYCON making an intercompany depreciable asset purchase of boardnetUSA, a proprietary board matching software from our affiliate, VCG.

Also in 2015, NYCON achieved cost and cash saving by refinancing the mortgage on our corporate headquarters in Menands. Savings were primarily re-invested into the purchase and customization of Salesforce, a content management software that aims to improve our service efficiency, program and product effectiveness, and customer service. The Board established designated funds from the annual operating savings with the intent of saving to meet the long-term debt obligation of the mortgage that will mature in 2025.

NYCON, as a whole, reported investment income of \$19,850 and realized and unrealized losses totaling \$22,932. The principal premium held in trust of \$198,000 remained whole.

Highlights of 2015 in comparison to 2014 are summarized below:

Additional comparative observations of note are:

- Total unrestricted revenue decreased 5% over last year and expenditures declined approximately 4%.
- Consolidated revenue sources for 2015 were: Fee for Service/Seminars & Administrative Service Fees 39%; CS Plus Commission Income 21%; Foundation Revenue 12%; Government Contracts 12%; Member Dues 6%; and Other Income 10%.
- At year-end, our Temporarily Restricted funds at fair value totaled \$78,934, after dedicating contributions toward Camp Finance Scholarships, technical assistance services and needed building improvements.
- The market value of the Group Employee Benefit Plan Administration Trust investment at fiscal year-end 2015 was \$237,536, inclusive of the principle investment of \$198,000.
- The market value of the Technical Assistance for Nonprofits & Communities Fund (TANC) at year-end was \$73,627 including \$53,673 in donor restricted funds.
- ❖ The market value for our board designated reserve fund for our historic corporate headquarters at year-end was \$5,307, of which \$5,288 is donor restricted dollars.
- The market value of board designated funds at year-end 2015 for the mortgage escrow was \$14,498.
- Council Services Plus, a for-profit social enterprise, reported a year-end total of \$194,940 in Net Assets, an increase in Net Assets of \$34,553.
- ❖ ICI reported year-end net assets of \$74,802, an increase of \$7,459 over 2014.
- ❖ VCG reported year-end net assets of \$21,280, an increase of \$7,343.

NYCON members, our stakeholders and supporters can be assured that our Board of Directors, led by our engaged Audit, Finance and Compliance Committee, and executive and financial staff are actively committed to continuing to demonstrate excellence in financial governance and management.




CONSOLIDATED REVENUE SOURCES FOR 2015
